### **TERMS**

#### ARTICLE 1 – GENERAL

- These general terms and conditions of sale of coverings of the designated stallion define the rights and obligations of the parties in connection with the sale of coverings. The buyer declares to have read it and accepts without reservation the rights and obligations relating thereto. Any breeding order is governed by these conditions.

- The buyer is aware of the conditions under which artificial inseminations take place. He will pass with the insemination center that he has chosen a separate accommodation agreement for his mare and in no case the seller can be held responsible for damage that may occur to the buyer's mare. 1-3 - The stud price does not include insemination fees, boarding fees, gynecological follow-up fees, any analyses, etc.

#### ARTICLE 2 – PROCEDURES APPLICABLE TO THE PROPORTION CONTRACT

The delivery of the doses cannot be triggered before the validation of the contract and the payment by the buyer. The buyer will contact the seller at the start of the season when his insemination center is ready to receive the doses. In general, the doses will be shipped within 24/48h, but it is possible that delays occur during busy periods. The buyer must anticipate the delivery of his sequins which can be delivered from the month of February.

#### ARTICLE 3 - GENERAL CONDITIONS OF SALE

- The shipment of the doses ordered will only be made after payment of the mating. If necessary and depending on the country, the declarations of birth will be sent to the buyer by e-mail, if and only if the payment has been made.

#### ARTICLE 4 - SALE OF FROZEN ARTIFICIAL INSEMINATION MOUTINGS

- When purchasing the mating contract, the buyer establishes a payment for the number of straws indicated above of frozen sperm. Additional doses will be the subject of another contract.

- The costs of setting up the seed are the responsibility of the buyer.

If the rest of the doses are used by the buyer, he must subscribe to a new contract to buy an additional mating card (reduced price). If the rest of the doses are used by a different contracting party, a new contract will be established as of right and the latter will have to pay the entire projection, except for transport. – Any modification of this contract (change of owner, change of mare, etc.) can only be made with the agreement of both parties, failing which a new contract will be required.

#### ARTICLE 5 – QUALITY OF FROZEN DOSES

A dose of frozen semen contains 0.5ml flakes which are concentrated to a minimum of one hundred million sperm/ml. The traceability of the semen we distribute is fully assured. Also, any dispute about the quality of the semen can only be taken into account if the applicant is able to provide us with the references of the ejacula; the color of the flakes as well as the information printed on the flakes (Standard name, identification number, batch number, and date of freezing.)

#### ARTICLE 6 – RIGHTS AND DISPUTES

The present conditions of sale of projection will be executed and interpreted in accordance with French law. In the event of a dispute, the buyer will first contact the seller to obtain an amicable solution. Failing this and in the event of a dispute for the application of the present, the dispute will be submitted to the competent courts within the jurisdiction of the domicile of SAS Colored Stallions.
